For participation in the **free** courses related to formative training under the aegis of The project FORMAZIONE PER L'ITALIA

Art.1 Purpose

The FORMAZIONE PER L'ITALIA project, funded by FAMI, promotes actions aimed at supporting legal immigration paths to Italy and involves the implementation of two Actions:

Action 1 - Language training course and assistance on entry into Italy lasting no. 110 hours for visa applicants to enter Italy for the purpose of family reunification.

Action 2 - Linguistic and professional training course lasting 200 hours for people qualified in the Information Technology sector, interested in obtaining an entry visa to Italy, even temporary, for reasons of subordinate work.

Art. 2 Participants

Tunisian / Ukrainian / Albanian /Bosnian /Indian citizens who have reached the age of 18, who are not recipients of judicial action, have not suffered convictions or limitations to their mobility.
